## **MEMBERSHIP**

The Crux Community is current limited to 75 members.

All Members are required to be active in the community which include, but not limited to: attending events, participating on the board and contributing to the community.

Members are reviewed semi-annually (in the Summer and Winter) by The Crux Delegates. Six months of inactivity will result in an inquiry if the member wishes to remain in the group and the request to participate in The Crux Community. Fail to participate may result in the removal from the group.

## **GUESTS**

Industry professionals who members believe can be an asset to the community can be invited as guest to The Crux Social events.

Unless otherwise noted in a Crux Social event, we request the following are not brought to The Crux Social events:

- Talent (Actors, Writers, Directors)
- Interns, Assistants
- Significant Others

## **ELIGIBILITY**

The Crux is an invite only organization. Members are voted in by The Crux Delegates on a rolling bases.

Factors taken in consideration for Membership include:

- Have held an executive or producer level position in the areas of development, representation, packaging, financing, or sales & distribution for Film, TV and Digital in the last 3 years.
- Has produced a feature length feature in the last 5 years.
- Has been recommended by at least 2 current Crux Community Members.

## **CODE OF CONDUCT**

The Crux Community was founded on respect for one another and of the entertainment industry.

- Insults and slandering of both members and non members will not be allowed on the boards. Negative rumors and gossip will also not be tolerated.
- Postings to The Crux Google Group message board should be limited to entertainment industry topics. Personal requests and announcements must be approved by The Crux Delegates.
